## **Booking conditions for Engine House Cottages**

The booking will only be definite when a cheque for £100 per week as deposit has been successfully banked. If the holiday is within 8 weeks of booking, the full price must be paid.

Full and final payment of the remainder must be paid 8 weeks prior to holiday commencement, the onus will be on the holiday maker to make the payment, without being reminded. Failure to pay the balance will constitute a cancellation of the holiday.

Should the holiday maker cancel the holiday, no moneys will be returned, therefore the onus will be on the holiday maker to be independently and adequately insured.

The property owner will not be responsible for any problems, costs, etc. incurred by the late arrival of the holiday maker. It is the responsibility of the holiday maker to contact the property owner prior to or during travelling for arrival information.

The property shall be vacated by 10.00am and may be ready for occupation by 3.00pm.

It is the responsibility of the holiday maker to leave the property as found, clean and tidy with no breakages. The property owner reserves the right to make additional charges if found otherwise.

All occupants must be listed on the booking form, with a maximum of 6 persons, excluding an infant using a cot.

The cost of all electricity and heating is included in the price. The property owner reserves the right to charge for any excessive use (i.e. holiday makers own heaters).

It is expected of the holiday makers party, that reasonable behaviour be used at all times, with due regard for other people using the property. (i.e. no excessive noise between the hours of 11pm and 7am).

We make every effort to maintain a clean and comfortable environment in the cottages and maintain all equipment to the best of our ability. However, breakdowns do occur and we cannot guarantee to repair any equipment faster than is reasonably possible, as it is not always certain that local tradesmen respond quickly.
